



ART UNION TERMS & CONDITIONS

Cross Code Charity Event Car Raffle

1. Promoter

The *Cross Code Charity Event Car Raffle* (“Art Union”) is conducted by **Holman Barnes Group** (“the Promoter”).

2. Authority

This Art Union is conducted under **Authority to Conduct an Art Union** number **GOCAU/2678** issued by NSW Fair Trading pursuant to the *Community Gaming Act 2018 (NSW)* and *Community Gaming Regulation 2020 (NSW)*.

3. Benefiting Organisations & Purpose

The net proceeds or a minimum of 30% of the gross proceeds of the Art Union (whichever is greater) will be paid to these charitable organisations as follows:

- **Foundation for A Bloody Great Cause Limited (ABN 81 632 588 713)** – 50%
- **Australian Sports Foundation Limited (ABN 97 179 064 897)** – 30%
- **Let’s Get Going (ABN 74 618 761 550)** – 20%

4. Eligibility

1. Entry is open only to **residents of New South Wales** aged **18 years or over**.
2. The following persons are ineligible to enter:
 - Employees and board members of Holman Barnes Group and their immediate families;
 - Persons conducting the gaming activity, including determining who is to win a prize in the gaming activity;
 - Persons involved in the management of any benefiting organisation.
3. Proof of eligibility may be requested.

5. Ticket Details

1. Ticket prices are:

- 1 ticket for \$10
- 3 tickets for \$25
- 5 tickets for \$40
- 10 tickets for \$70

2. Tickets will include

- Price
- Name of organisation conducting the art union
- Benefiting organisations
- Authority number

3. Ticketing errors

A player's right to a prize is not affected due to an error in the production of tickets.

1. A maximum of 20,000 tickets will be sold.
2. Ticket sales commence **28 January 2026**.
3. Ticket sales close **21 February 2026 at 3:45pm**, unless sold out earlier.
4. Each valid ticket represents one entry into the draw.

6. Prize

1. The prize is **one (1) Mazda CX-5 Maxx**.
2. The total retail value is **\$41,290 driveaway**
Mazda Australia has a current promotion showing the vehicle at \$38,785 as a promotional driveaway price but the full price is \$41,290.
3. The prize:
 - Is not transferable
 - Is not redeemable for cash

 - 12-month registration in NSW

7. Draw

1. The draw will take place:

- **Location:** Concord Oval, Loftus Street, Concord NSW

2. A digital draw will be conducted.

3. The draw will be conducted in public.

4. The Promoter's decision is final.

8. Winner Notification & Publication

1. The winner will be:

- Announced onsite at the draw, and
- Notified by email using details provided at entry.

2. The winner's name will be published on the Promoter's website.

9. Unclaimed Prize

1. Every reasonable effort will be taken to contact the prize winner.

2. If the prize is not claimed within **14 days**, it will be forfeited and a redraw will be conducted.

3. The redraw will occur at the same location, or as otherwise approved.

4. The redraw winner will be notified and published in the same manner.





10. Records

The Promoter will maintain records relating to ticket sales, financials and prize distribution for **a minimum of 7 years** and will provide access to NSW Fair Trading upon request.

11. Privacy

Personal information will be collected and used solely for the purposes of conducting the Art Union and comply with legal obligations.

12. General

1. The Promoter reserves the right to verify entries and disqualify any entrant who breaches these Terms & Conditions.
2. Disputes will be resolved at the Promoter's discretion, subject to regulatory oversight.
